**NOTICE AND ORDER TO ALL PEACE
OFFICERS OR OTHER OFFICIALS**

Released Oct. 2016

Notice:

We, the ANPC International Nation, as a private independent nation of Private American nationals of the several union states, are alerting you to the fact that a number of our nation's members may be travelling through your local area from time to time using our nations privately issued travel credentials.

Purpose: To give Notice to any/all government agents of Your fiduciary duty to honor our private nation and travel documents that identify our private members' national status and their right to travel. **See EXHIBITS A (1-4.)**

Terms: *As private American nationals, we gratefully accept your official oath/s of office to protect and defend our God given unalienable rights.* Our members are peaceful and wish to harm none but rather to promote peace and betterment for all peoples and nations, and shall under no circumstance be erroneously termed as "sovereign citizens" or any such term.

Charter: Our Private Nation's Charter, organized as a Nation Government (No: 831699984) has been filed with the United Nations, The Hague and the World Court as well as Notice given to every Secretary of State and State Trooper unit in all of the 50 union states.

Identification: Our Nation's Private Identification documents have also been Registered and Copyrighted as well as Authenticated and given Full faith and Credit by the United States of America Department of State, having Full Faith and Credit Global Record Numbers: 14051874-13 and 14051874-14 being signed by John F. Kerry on or about 28 August 2014. **SEE EXHIBIT B.**

Financial Responsibility: Our Nation is also fully Bonded and indemnified against all liabilities by and through Surety Bond Numbers: RE115177165US, RE115176810US and further Registered through USPS Number: RE115176820US and a CLAIM has been stated on the UCC # 2017-270-4942-0. **SEE EXHIBIT C.**

Documentation: ANPC International also has a Federal District Court Case, opened on Fri, 6 Feb 2015 15:34:18 -0600, which was assigned case number 6:15-mc-00101-EFM to be used in the event of human rights violations or any infringement violations of any kind upon our members.

Members oaths and allegiance: Our members have each taken an oath or made a promise to live and travel peacefully and harm no man and our members domestically have an oath of absolute allegiance to the collective republic states which are united by and under the Constitution¹, the Articles of Confederation and Perpetual Union whereby taking the name of 'the United States of America' and are nationals of their respective states.

In the event that one of our members fails to uphold their oath/promise and cause undue disturbance or injury to another man or woman, we ask that you contact our nations embassy immediately at one of the above listed contact methods and send us an affidavit of the facts of the disruption or injury so that we can indemnify the injury and deal with said member to insure peace accordingly per our nations rules and behavioral codes.

Your oaths: We, ANPC, believe that You have an oath to support and defend the constitution² from all enemies foreign and domestic. We strongly urge you to follow the below orders to prevent "domestic violence" against our members from those "officers" who may be ignorant of our political status as nationals.

Orders and honor:

1. Orders: It is hereby ordered that your office promptly enter all the attached identifications, exhibits and car tags individually and severally, into all local databases, NCIC Law Enforcement and NICS Check systems nationwide.
2. To avoid any confusion or unnecessary actions/claims upon unaware peace officers, it is ordered that Your office update Your NCIC and NICS databases with this information and for Your databases to reflect for all ANPC members -DO NOT DETAIN, DO NOT HOLD, DO NOT QUESTION-, so all officers under Your leadership are aware of this nation's presence, her members and their standing to avoid any violence against ANPC members for their claim of exercising a right guaranteed under the constitution.
3. Infringements or violations may result in actions upon the violator and charges of rights violations to the full extent of the law. For your reference, we have attached exhibits of three Letters from state Senators, Representatives and Georgia

5. Any objections MUST be sent to one of the above listed contacts within said time frame accompanied by THREE VALID lawful reasons why you do not choose to honor this order. All objections MUST fall under the United Nations Declaration of Human Rights which was adopted by our Nation and which overrules ALL mere municipal statutes or codes.

Dear Director Milstead:

It has come to my attention that numerous individuals in our state have rescinded all of their contracts with the United States federal government, the State of Arizona, and each of its political subdivisions, establishing themselves as freemen under the organic national Constitution of the Republic of the United States of America. Consequently, they may be driving without auto registration, driver's license, or any other evidence of contract.

Because many law enforcement personnel may be unaware of the contractual nature of auto registration and driver's licenses, it is conceivable that this situation may lead to confrontation between these individuals and law enforcement personnel.

I urge you to inform yourself and your personnel about this matter as soon as possible. If you would like to be briefed by someone knowledgeable on this subject, please contact me.

In the meantime, inasmuch as this procedure is entirely appropriate when properly carried out, I would like to be personally notified of every such instance of confrontation in order that the persons involved and the public officials involved may be apprised of the correct procedure and the appropriateness of their actions on the part of each concerned.

My office phone is 255-5261 and I am requesting to be notified of the names and incidents along with addresses and phone numbers of participants of any such confrontations arising from the exercise of a person's freeman status in order to evaluate the outcome of properly rescinded contracts.



Dear Judge Streitl:

It has recently been brought to my attention that on March 26, 2006, Mr. William Taylor Reil, a defendant in Criminal Action Number 4470-02 before the Court of Common Pleas, was found guilty of violating two provisions of the Transportation Code, 75 Pa. C.S.A. § 7122 (3) and 75 Pa. C.S.A. § 1543 (a).

I have come to know Mr. Reil very well during the past 14 years and I respect his understanding of the law concerning the right of an individual to travel, among other things. I believe Mr. Reil has a better understanding of this area of the law than many licensed attorneys.

While I am not a licensed attorney, I have asked a member of my staff who is a Pennsylvania licensed attorney to examine Mr. Reil's understanding of this complex issue. The conclusion reached by my staff member was that Mr. Reil has thoroughly researched the issue and has based his arguments on solid legal precedent. I have also performed my own in-depth research over the years and I, too, have reached the conclusion that Mr. Reil stands on solid legal footing.

The crux of the issue is whether Title 75 can properly be applied to an individual. Within an individual's right to liberty is the inherent right to travel. If one's movement can be restrained, such restraint is intrinsically a restraint of his liberty. Mr. Reil's use of an automobile is simply an extension of his personal liberty to move about as he wishes.

My research, and that of my staff, confirms that Title 75 can only properly be applied to commercial vehicles and commercial use of the roads. An individual who wishes to utilize an automobile or other means of conveyance in order to exercise his right to travel cannot lawfully be required to obtain a license to drive or to register his automobile in order to operate it freely on our roads.

I have not reached the above conclusions without understanding the vast implications that would follow from these conclusions. I am well aware that a ruling of this nature would “undo” years of enforcement of our existing laws. I am also well aware of the enormous economic impact such a ruling would have on the Department of Transportation.

However, no one today would dare argue that we should not have eliminated slavery because it was too costly to the American economy. When rights are being violated, no cost is too high to return those rights to the individuals who hold them. Slavery is the ultimate restriction of one’s liberty. It limits one’s rights in every conceivable way, including one’s right to move about freely. Likewise, refusing to acknowledge an individual’s right to travel is an unconstitutional restriction of one’s liberty and should not be permitted to continue in Pennsylvania.

I respectfully request that you grant Mr. Reil’s request for reconsideration of the March 27 verdict and review the facts and circumstances surrounding his request. He does not wish to perpetuate this situation any more than necessary; he is simply asking for an acknowledgement and protection of his right to travel and would like to return to living the peaceful life he has led over the years.

I would certainly be happy to speak with you concerning this issue if you would like to do so. I appreciate your willingness to consider the views I have expressed in this letter.

State Rep. Bobby Franklin Of Marietta Defends House Bill 7

ATLANTA -- A state lawmaker from Marietta is sponsoring a bill that seeks to do away with Georgia driver's licenses.

State Rep. Bobby Franklin, R-Marietta, has filed House Bill 7, calling it the "Right to Travel Act."

In his bill, Franklin states, "Free people have a common law and constitutional right to travel on the roads and highways that are provided by their government for that purpose. Licensing of drivers cannot be required of free people, because taking on the restrictions of a license requires the surrender of an inalienable right."

Franklin told CBS Atlanta News that driver's licenses are a throw back to oppressive times. "Agents of the state demanding your papers," he said. "We're getting that way here."

CBS Atlanta's Rebekka Schramm asked Franklin, "How are we going to keep up with who's who and who's on the roads and who's not supposed to be on the roads?"

"That's a great question," Franklin said. "And I would have to answer that with a question, 'Why do you need to know who's who?'"

"What about 12-14-year-olds who want to drive? What would stop them?" Schramm asked.

"Well, what's stopping them now anyway?" Franklin answered.

But not all drivers are on board with the lawmaker's idea.

"I think people should be qualified in some way to drive," Susan Cotton said.

"It's kind of dumb. We need to focus on more important things. The system is working," Sheriyar Sarkari said.

Franklin's name is on the first 21 bills of the legislative session, including one that would require the exclusive use of gold and silver as tender in payment of debts by or to the state, as required in the Georgia Constitution.

"Can the state really pay in gold and silver?" Schramm asked.

"Sure, and they can write checks on it," Franklin said. "They can use a debit card as long as what's denominated behind it is gold and silver."

Franklin is also behind House Bill 11, which would repeal the authority of the governor to issue mandatory vaccination orders. "I'm a firm believer that no person should be subjected to an invasive medical procedure without their consent," he said.

"Have you ever had critics say, 'Look, some of these bills are a waste of paper?'" Schramm asked.

"I can't speak for what other people think," Franklin said. "I just know I took an oath to uphold the Constitution, and that's what I'm trying to do."

House Bill 7

By: Representative Franklin of the 43rd

A BILL TO BE ENTITLED
AN ACT

1 To amend Title 40 of the Official Code of Georgia Annotated, relating to motor vehicles and
2 traffic, so as to repeal Chapter 5, relating to drivers' licenses; provide for a short title; to
3 report the findings of the General Assembly regarding the constitutionality of certain laws
4 relating to drivers' licenses; to provide for an effective date; to repeal conflicting laws; and
5 for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 This Act shall be known and may be cited as the "Right to Travel Act."

9 **SECTION 2.**

10 The General Assembly finds that:

11 (1) Free people have a common law and constitutional right to travel on the roads and
12 highways that are provided by their government for that purpose. Licensing of drivers
13 cannot be required of free people because taking on the restrictions of a license requires
14 the surrender of an inalienable right;

15 (2) In England in 1215, the right to travel was enshrined in Article 42 of Magna Carta:
16 It shall be lawful to any person, for the future, to go out of our kingdom, and to return,
17 safely and securely, by land or by water, saving his allegiance to us, unless it be in time
18 of war, for some short space, for the common good of the kingdom: excepting prisoners
19 and outlaws, according to the laws of the land, and of the people of the nation at war
20 against us, and Merchants who shall be treated as it is said above.

21 (3) Where rights secured by the Constitution of the United States and the State of
22 Georgia are involved, there can be no rule making or legislation that would abrogate
23 these rights. The claim and exercise of a constitutional right cannot be converted into a
24 crime. There can be no sanction or penalty imposed upon an individual because of this
25 exercise of constitutional rights;

26 (4) American citizens have the inalienable right to use the roads and highways
 27 unrestricted in any manner so long as they are not damaging or violating property or
 28 rights of others. The government, by requiring the people to obtain drivers' licenses, is
 29 restricting, and therefore violating, the people's common law and constitutional right to
 30 travel;

31 (5) In *Shapiro v Thompson*, 394 U.S. 618 (1969), Justice Potter Stewart noted in a
 32 concurring opinion that the right to travel "is a right broadly assertable against private
 33 interference as well as governmental action. Like the right of association...it is a virtually
 34 unconditional personal right, guaranteed by the Constitution to us all." The Articles of
 35 Confederation had an explicit right to travel; and we hold that the right to travel is so
 36 fundamental that the Framers thought it was unnecessary to include it in the Constitution
 37 or the Bill of Rights;

38 (6) The right to travel upon the public highways is not a mere privilege which may be
 39 permitted or prohibited at will but the common right which every citizen has under his
 40 or her right to life, liberty, and the pursuit of happiness. Under this constitutional
 41 guarantee one may, therefore, under normal conditions, travel at his or her inclination
 42 along the public highways or in public places while conducting himself or herself in an
 43 orderly and decent manner; and

44 (7) Thus, the legislature does not have the power to abrogate the citizens' right to travel
 45 upon the public roads by passing legislation forcing the citizen to waive the right and
 46 convert that right into a privilege.

47 **SECTION 3.**

48 Title 40 of the Official Code of Georgia Annotated, relating to motor vehicles and traffic, is
 49 amended by repealing Chapter 5, relating to drivers' licenses, and designating said chapter
 50 as reserved.

51 **SECTION 4.**

52 This Act shall become effective upon its approval by the Governor or upon its becoming law
 53 without such approval.

54 **SECTION 5.**

55 All laws and parts of laws in conflict with this Act are repealed.

RE: VIOLATION OF U.S. SUPREME COURT RULINGS REGARDING THE RIGHT TO TRAVEL

SUBJECT: EDUCATION OF LAW ENFORCEMENTS AND NORTH CAROLINA JUDICIARY

Dear Governor McCrory,

We are sending this correspondence to make you aware of the unconstitutional acts committed by your law enforcement agencies and state courts against the people of North Carolina. These acts may or may not have been committed knowingly or unintentionally but we are writing to your office to ensure that these violations are brought to your attention so that they can be addressed and corrected.

As you may or may not know, there are people in your state whose status is ostensibly different than the average US Citizen and are considered Foreign Nationals or American Nationals with certain safeguards and protection under the law. Our primary concern is that their travel rights in your state are not infringed.

In order to educate your law enforcement regarding Foreign Nationals or American Nationals in your state, you can call the Department of State here in Washington, D.C. to get clarity or you can go to the Department of State's website at http://travel.state.gov/content/dam/travel/CNAtrainingresources/CNAManual_Feb2014.pdf for our website at https://www.usadot.gov.org/CNAManual_Feb2014.pdf and download the manual. The Department of State also offers training for your law enforcement officers free of charge to raise awareness and compliance. Log on to: <http://travel.state.gov/content/travel/en/consularnotification/training-outreach.html>.


We have enclosed one of our affidavit forms for the exemption of registration and licensing for Foreign Nationals that Foreign Nationals have to file in your state to lawfully claim the exemption. This affidavit also can be used by U.S. Citizens who are not driving or operating a motor vehicle for profit or for hire.

Please forward this information to all of your law enforcement agencies in your state to prevent any unnecessary lawsuits from being filed against these agencies for not following the law and violating the rights of the people to freely travel without interference unless they are a threat to the public safety.

If you have any questions regarding this matter please feel free to respond in writing by mail or fax any questions or concerns you may have and we will be happy to answer and address them.

Thank you in advance for your cooperation and consideration in this matter.




2021 Version Front
